## **CONGRATULATIONS!**

& THANK YOU FOR CONSIDERING MY SERVICES

Working in the industry for over 5 years now, and being a past bride myself, I understand the effort that goes into wedding planning. Allow me to take on the work of the makeup portion of the planning plate: reaching out to schedule sessions, bringing all of the products needed to complete the job, and more!

To ensure a streamlined inquiry and booking process, please respect the booking polices listed below

- Please make sure to review my availability for your wedding day on the Booking page before filling out the inquiry form.
- To ensure that I have full understanding of your expectations, it's important that our communication is 1:1
- In order to finalize and initiate the booking process, I will need two things: A signed contract and a **non-refundable non-transferable \$100 retainer**. This fee serves as a commitment from both parties and ensures that I am exclusively available to cater to your needs during the agreed-upon period. This is a separate fee from your day-of invoice. Once I have received both the signed contract + retainer, I will lock you into my calendar. You do have a 24 hour grace period from the time the contract has been sent to sign and pay your retainer, otherwise your date is void and becomes available for others to book.
- I require a minimum of the bride + 4 others OR the price equivalent for all wedding services on Fridays, Saturdays, and Sundays (see Wedding Makeup Package below)
- Investment cost is subject to change at any time. Only contracted rates will be honored.

## ALL INCLUSIVE MAKEUP PACKAGE

#### WEDDING MAKEUP PACKAGE - \$1,200

This is my minimum package requirement for weddings held on Fridays, Saturdays, and Sundays.

- Bride + 4 others
- Trial session for the bride at my studio in Buffalo, WY (with bubbly of course!) and on-site wedding day applications (both allotted for 1 hour and 30 mins)
- Customized skin preparation for the trial + wedding day (Includes depuffing undereye patches; due to timing, these are offered for the bride only)
- Personalized makeup timeline
- Touch Up Kit for the bride (straw, mints, sponge, powder puff, powder, lip brush, lip color, oil blotting sheet, tissues, makeup wipes and q-tips)
- Lashes for ALL applications
- Touch ups for everyone before I leave for fresh lips and a shine-free face
- Complimentary travel within Johnson County limits (\$1/mile round trip for locations outside of JC limits.)

### A LA CARTE ADD ONS

#### MAKEUP APPLICATION

\$140/person - Skin preparation, makeup application, and lashes **ADDITIONAL ARTIST** 

\$250 An additional artist is applied to bookings of 8-12 people to help shorten the timeframe. All travel and lodging fees apply to the additional artist as well.

#### TOUCH UP KIT FOR WEDDING PARTY

\$30/each - Includes: straw, mints, sponge, powder puff, powder, lip color, lipstick applicator, oil-blotting sheets, compact mirror, makeup wipes, q-tips, tissues, and eye patches

#### ON-LOCATION TOUCH UPS AT THE VENUE

\$150/hour + travel (if applicable) The best way to ensure your makeup is as fresh as possible. I stick around before/after the ceremony to touch up you and your crews makeup and make sure you're all picture perfect. More information is provided in my reply if you're interested!

## TRAVEL & OTHER FEES

#### TRAVEL

Complimentary for locations within Johnson County \$1/mile round trip will be added on for locations outside of Johnson County limits

#### ACCOMODATIONS

Hotel accommodations are required the night prior if location is 2+hrs away (one way) from me. **START TIMES EARLIER THAN 7 AM** 

\$50/hour/artist - This cost is not applied up front but will be determined when the timeline is made closer to the wedding

#### HOLIDAY FEE

\$100 Applied to the following observed holiday weekends (Friday-Monday): Memorial Day, Independence Day, and Labor Day. Weddings are not scheduled on Thanksgiving, Christmas, and New Years weekends!

## THE RUNDOWN

## • Here are a few important things to know about the process of working with me **PAYMENTS**

If you're ready to go forward, a \$100 retainer payment alongside a contract signature will be due! The retainer does not go toward any services. 1/2 the total contract price is due 2 months in advance and the remaining balance is due one month before the wedding date.

#### TRIAL

3 months up to the wedding, I'll reach out to schedule your trial. Your trial is already included in your investment! I schedule trials 1-2 months before the wedding date. **TIMELINE** 

We create your timeline after the trial has concluded! By this time, information like headcount, location, and service end time (determined by your photographer) should be confirmed to create a timeline. **TOUCH UPS** 

Within the time I'm with you on your wedding day, I also provide touch ups before I leave as well as a required 30 minute buffer time at the end to keep any delays that could arise from running the day behind

#### COMMUNICATION

There are a few of ways in which I'm big on communication: You'll receive a reply to emails within the same day or the next business day. To keep everything streamlined, all emails are within our HoneyBook portal! I text you 2 days before the wedding to confirm location and the time I'll arrive and the morning of when I'm on my way and when I've arrived. When we have your trial/wedding day/makeup application, you're in a safe space to communicate anything you want to change about the look. I'm very receptive to feedback and want you to feel your best! If there's ever a time that you'd like to hop on a quick call for something, never hesitate to ask!

## FAQ'S

#### WHAT IF I DON'T HAVE A HEADCOUNT?

We will start with my minimum and go from there! People can be added on up to the wedding, but please note that the price will remain firm if anyone opts out.

WHAT IF I DON'T HAVE ENOUGH PEOPLE TO MEET THE MINIMUM?

You're able to substitute the remaining applications for wedding events such as engagement photos, bridal shower, or rehearsal dinner!

#### CAN I HAVE A TRIAL BEFORE BOOKING?

Since trials do not hold dates, they're reserved for booked clients! If you have any specific questions or concerns, I'm more than happy to hold a quick phone call!

## **NEXT STEPS**

- 1. If you like what you see, fill out the inquiry form on <u>this page</u>! Please remember to review my booking policies and availability before submitting.
- 2. Within 1-2 days of submitting the form, you'll receive an email from me with your personalized quote. If you have any questions about my services, don't hesitate to let me know - I'm here to help!
- 3. The ball is in your court to let me know what you're thinkin' and if you'd like to go forward once you receive my email, but I typically reach out a week after this email is sent to give you enough time to discuss any details if needed! Please note that I work on a first-come-first-serve basis, so if I don't hear from you after I follow up, I will move onto the next inquiry for your date.
- 4. At any point after you get my email that you let me know you'd like to go forward (if I'm still available), I'll send you the proposal of services which includes an itemized invoice, payment schedule, and contract! The retainer must be paid within 24 hours of booking your date or it will move to the next inquiring bride.
